The reporting party, later identified as Contrary to public interest - C.R.S., reported issues with cyberbullying at the business. Con reported the business is getting threats about harming people there. I spoke with Con via phone and he reported the following: stated Good Judy's is hosting an event for the school board campaign. Cont stated the bar's Facebook page was receiving threats. appeared concerned that an incident may occur at the event. Con stated the event was on 10/16/23 at 2000 hours. Con stated the bar was LGBT affiliated and believes this is why the bar was receiving threats. the individual and wanted the police to be aware of the situation. Con stated that he would send screenshots of the threats to me. I reviewed the Facebook comments and the following is a summary: In the photo, a Facebook user Contrary to public states "Time to clean up lots of problems at once".

I booked the photos into evidence.

At this time, there is no probable cause for any charges. I will reopen the case if any other information presents itself.
