On Saturday, February 15, 2020, at approximately 0803 hours, Officer Rose and I responded to 2512 Filmore Avenue, in Grand Junction, Mesa County, Colorado to conduct follow up reference incident 2020-00007945. I went to the front door and rang the doorbell and knocked on the front door. There was no response from inside for several seconds. I looked inside the front window to the right of the door and did not observe anyone inside. I then knocked on the front door again.

Officer Rose was looking through the window on the right side and stated he observed someone coming to the door. Officer Rose then advised he observed the male put a gun in his holster. I went to the east side of the front of the house and Officer Rose remained near the garage.

A male, later identified as Michael Deuel DOB 061163, stepped out of the front door and Office Rose contacted him outside of the front door. Deuel left the front door open, and I could observe a large, long-barrel revolver that had been placed on a bench near the front door.

Deuel stated he had initially placed the gun in a pocket of the clothing he was wearing. Officer Rose conducted a frisk of the male for further weapons, and did not locate any further weapons on his person.

Officer Rose asked Deuel why he went to the deputy's house, and Deuel started making statements in regards to the deputy being deposed reference a divorce that Deuel went through. Officer Rose and I advised Deuel not to return to the deputy's address and that he could be arrested for trespassing if he did so

Office Rose then advised Deuel to place his hands behind his back and that he was going to detain him in handcuffs. Deuel made the statement, "You don't need to do that".

As Officer Rose was attempting to place handcuffs on Deuel, I turned to my right to get Deuel's sweatshirt that was on the ground. When I stood back in front of Deuel on his right side, he used his right arm and grabbed my right shoulder. I pushed Deuel's right shoulder back and then pushed on his chest and told him, "Stop! Don't grab me."

Deuel continued to resist and Officer Rose went to Deuel's left side as I attempted to maintain control of his right side. I first felt Deuel try to grab my taser on the left side of my body. I then felt Deuel reach around the top of my back with his right hand and arm, grabbing under my right arm pit. I yelled, "Let go of me. Let go of my back!".

Deuel made the statement, "I watch cops. I know what you guys do". I made the statement to Officer Rose, "Go slow, go slow," as we gained control of Deuel and brought him to his knees on the sidewalk. I told Deuel to put his hands behind his back.

I maintained control of Deuel's head and top of his shoulders against the right side of my body, as I brought his right arm behind his back and Officer Rose placed handcuffs on his wrists. Deuel made the statement, "You're gonna kill me." I told Deuel again to stop resisting, and he stated, "I'm not resisting. I want to get my feet not cold."

After Deuel was detained, I advised Officer Rose to contact Sgt. Ancell, who was the on duty supervisor at the time. I closed the front door to Deuel's residence.

Neither Officer Rose or I sustained any injuries while detaining Deuel. Deuel did not sustain any injuries as well. Officer Rose asked Deuel if he was injured, and he stated he was not.

Deuel continued to make statements in regards to his divorce. During our contact with Deuel, he asked multiple times if Officer Rose and I had our body cameras recording, and we advised him we did.

Deuel continued to make statements in regards to his divorce and deposing multiple people he knew in

regards to his divorce. Deuel sounded confused as we spoke with him.

During the course of the investigation, Deuel was issued a summons for obstruction.

A BWC was used during this investigation. The following is a summary and is not an all-inclusive or verbatim account of what occurred

On February 15, 2020 at about 0803 hours I responded to 2512 Filmore Avenue in Grand Junction, Mesa County, Colorado 81505 to conduct follow-up reference GJPD case 2020-00007945. An unidentified male had approached a residence at 2514 Hayes Drive where he tried the door knob and rang the doorbell. He then walked over to a front window and began banging on it. During the above GJPD case it was determined the resident of 2514 Hayes Drive was a law enforcement officer who was identified as a Deputy with the Mesa County Sheriff's Office.

At some point when the unidentified male was on the property of 2514 Hayes Drive he made statements about someone inside the residence being a "cop." This indicated the male suspect was privy to the fact that a law enforcement officer lived at this address. A female resident was inside when the male attempted to open the front door of the residence. When the male didn't get an answer at the door he left eastbound on Hayes Drive. The door to the residence was locked.

A male was identified as a suspect in this case as Michael Deuel DOB: 06/11/1963 through local law enforcement records. The residents at 2514 Hayes Drive had a Ring doorbell security system that showed a male with similar characteristics to Deuel. It was also determined Deuel lived at 2512 Filmore Avenue. This residence is located on one street to the north of 2514 Hayes Drive. I responded to speak with Deuel about unlawfully entering onto someone's property and attempting to gain access to their house by trying to open the front door.

Ofc. Naik responded with me and we made our way to the residence where Ofc. Naik knocked on the front door and rang the front doorbell. Initially we did not get an answer. I was standing near the front door and looking through a front window on the house. As I was looking through it appeared a male was making his way to the front door. I got a better look at the male as he made his way to the front door and I observed a black object in his right hand. It also appeared the male walking to the door was in fact Deuel. I had seen a photograph of Deuel prior to attempting to contact him at his residence.

Upon looking closer I observed what looked like a black handgun in his right hand and it appeared he was trying to put it in his front right pocket of his pants. I told Ofc. Naik to step back due to my observation that Deuel appeared to have a handgun in his hand.

Deuel opened the door and I asked him what he put in his pocket and he stated, "I took it out." He then stepped out of the doorway and I had him place his hands behind his back. I asked him again what he had in his pocket and he confirmed he did have a gun on him when he was making his way to the door. I conducted a pat down frisk for weapons on Deuel and didn't locate any weapons on him. Deuel made a statement that he knew why law enforcement was at his residence. It was concerning to me that if he was aware it might be law enforcement that he would bring a handgun with him towards the front door.

I spoke with Deuel and the following is a summary of our contact. I asked Deuel why he was

going over to the deputy's house that lived down the street and he stated, because he is "deposing" himself. During the contact, Deuel made several statements that were odd. He claimed that his neighbors were out to get him and he made statements about people trying to kill him. During the contact, Deuel claimed he had called the "FBI" and hasn't received any help. He provided this as a reason to why he attempted to get in contact with the deputy who lived at 2514 Hayes Avenue. He told me that he was going over to 2514 Hayes Avenue in an effort to get some help. Ofc. Naik explained to him that he needed to properly report information to the police.

During the contact myself and Ofc. Naik were explaining to Deuel that we were formally advising him that he was not allowed on the property of 2514 Hayes Avenue. We explained to him that if he went back there he could be charged with trespassing. While speaking with Deuel he was verbally not cooperative. Based on him not being cooperative and coming to the door with a weapon I told him that I was going to detain him in handcuffs. I was also going to detain him in handcuffs for the trespassing incident.

I had him place his hands behind his back and he initially complied. When I grabbed onto Deuel he stiffened his arms and began turning towards me and was non-compliant. I know based on my training that when suspects turn towards an officer when they are effecting a detention they can resist. I attempted to handcuff Deuel and he moved his arms outwards and was resisting and this was preventing me from detaining him in handcuffs.

The following is what happened next. I had to gain control of Deuel's left arm and Ofc. Naik had to gain control of Deuel's right arm. I heard Ofc. Naik initially tell Deuel to take his arm off Ofc. Naik's back. Myself and Ofc. Naik had to escort Deuel to the ground in order to effect the detention. I also had to physically gain control of both of his hand's to get the handcuffs on the hands.

Deuel was taken to his knees where I eventually was able to place handcuffs on him. After detaining Deuel in handcuffs the homeowners of 2514 Hayes Drive were contacted and they advised they did not want to press charges for the trespassing incident from GJPD case 2020-00007945.

I released Deuel on a summons for obstructing a peace officer (18-8-104).

A BWC was used during this investigation. The following is a summary and is not an all-inclusive or verbatim account of what occurred. Please review BWC footage for further details.

I was asked by members of the Mesa County District Attorney's Office to complete a supplemental report regarding the reasoning for handcuffing the defendant, Michael Deuel DOB: 06/11/1963, at his residence at 2512 Filmore Avenue in this case.

I responded to Mr. Deuel's residence to follow-up on an incident where he went to a Mesa County Sheriff's Office Deputy's residence and attempted to open the front door and gain access. At the time Mr. Deuel made the decision to attempt to gain access to 2514 Hayes Drive there was a female (deputy's wife) and children inside the residence.

When I responded with Ofc. Naik to Michael's residence he came to the door with a revolver handgun and set it down directly inside the door prior to answering it. Michael's cooperation level was up and down during the contact.

Michael was detained in handcuffs because probable cause was established that he committed attempted first degree criminal trespass (felony 6). After the detention, the homeowners of 2514 Hayes Drive were contacted and indicated they didn't want charges pressed for the attempted trespass.

Based on Michael's decision making of trying to gain access to a neighbor's residence, coming to his door with a handgun and him making several bizarre statements during the contact it was additionally determined he was a danger to himself and other's. As a result, at the time of handcuffing, probable cause existed to place Michael into protective custody.
