On 10/09/2023 at 2147 hours, I was dispatched to a threat being made, at Good Judy's, at 103 N 1st Street, in Grand Junction, Mesa County, Colorado. The reporting party, later identified as [Contrary to public interest - C.R.S.], reported issues with cyberbullying at the business. [Con] reported the business is getting threats about harming people there.

I spoke with [Con] via phone and he reported the following:

[Con] stated Good Judy's is hosting an event for the school board campaign. [Cont] stated the bar's Facebook page was receiving threats. [Con] appeared concerned that an incident may occur at the event. [Con] stated the event was on 10/16/23 at 2000 hours. [Con] stated the bar was LGBT affiliated and believes this is why the bar was receiving threats. [Con] stated he wanted to pursue charges against the individual and wanted the police to be aware of the situation. [Con] stated that he would send screenshots of the threats to me.

I reviewed the Facebook comments and the following is a summary:

In the photo, a Facebook user [Contrary to public] states "Time to clean up lots of problems at once".

I booked the photos into evidence.

At this time, there is no probable cause for any charges. I will reopen the case if any other information presents itself.
