I spoke on the phone about and having a burden of evidence but refusing to charge my boyfriend with spoke to him about the denial of my medical grievance and asking for my inmate rights. I also explained how I was retaliated against by sheriffs booking deputy's retaliation against me for asking for a grievance, then moving me to restricted housing because I asked for the inmate rights and policies and then asked for a grievance. He said I was making a disturbance I told him to they told me to go and self express my breast milk in a intake bathroom I told them No, my baby needed my milk and then asked for my inmate rights and policies they retuned me back to general booking housing cell, I knocked on the cell door and asked for a grievance at the same voice level as if I was asking for a roll of toilet paper. Upon asking for a grievance the deputy's asked me to step out of my cell and put me in a Conor padded cell with no toilet I told him I asked for them to call and get my Brest pump upon arrival at the jail. I also advised him that when I was moved to restricted housing that deputy's came and did their 30 minutes checks and when they came to look in my cell I asked to use the bathroom I told him that the deputy pointed to the hole in the ground with a grate and said "right there" I told the booking deputy "your lying" and he replied "I'm not" he instructed me to defecate in the whole in the ground. Internal affairs replied "yea everyone in those assigned to those cells use the drain gate to use the bathroom not a toilet" I told him that is very wrong and then he asked me some of the staff the witnessed the incident I asked him who the bald man on the computer is he seen the whole incident and refused to help me and looked as if he knew better he let me know that is their "booking supervisor" he did not take my full report of the cruel and unusual punishment that is happening in the jail. He said they don't give grievances to people unlikely to be housed. He also said there is no camera footage of when I was booked in on may 27,2025he didn't anything and everything to sway me that what is happening in the jail is okay. OTHER KNOWN INCIDENTS: Yes

toilet. They are to use the drain hole with a grate covering. They are accepting dementia at risk adults for trespassing and not taking protocol even if they noticeably have this illness, personally witnessed this and want to say more but don't want to run out of space. When I was jailed in June I witnessed the jail and multiple deputy's commit neglect on an at risk adult there was an most likely identified as African/amrican around the age of 65 or older who had inconsistency habits she had diarrhea that leaked out of her depend. We asked them for 5 hours or more for them to please get her a new diaper and clothing because she had a soiled diaper and clothing. The cell had a afwful smell of fecal matter it wasn't until one of the women vomited did they get her a diaper and new clothing they exposed me to many communicable diseases and put me and others at high risk for Escherichia coli (E. coli), Salmonella, Shigella, Campylobacter, Cholera, and Typhoid fever. Viruses like Hepatitis A, Hepatitis E, Rotavirus, Adenovirus, and Norovirus. They did not care or take concern. They make people poop in a hole in the ground on a daily basis in restrictive housing. I have names dates and times of these events including the name of the witness who vomited after being exposed to fecal matter for 5 hours. They do not provide hand soap, tooth brush,

nor a comb and do not offer a shower until you are in permanent housing.

incarcerated inmate at Mesa county Jail upon arrival at the jail I told them I have a 13 week old baby who is exclusively breastfeeding and is solely reliant on my breast milk. I gave them a phone number they could

call for me to acquire my breast pump and asked them to please call since my newborn is not likely to accept formula since he has never drank it so it's very important to get the infant my milk urgently. The

booking deputys don't book you completely in until several hours later with a phone call being last priority. I also was told by medical

staff that I did not require the special diet because that's "only

housing cell I waited 2 1/2 hours into my incarceration before asking booking deputy's if they were able to make the phone call to have my breast pump delivered to the jail they said "No, we can't do that." I asked if they could please ask the nurse to call. The nurse about 10-15

cell she started walking me near the intake bathroom she tried handing me a wash cloth and said "here if it's bad enough you can go self express
